- You shall not be eligible or entitled to participate in the Event and no binding contract shall exist until LNAA have provided you with written confirmation that the application was successful, and you have paid your registration fee in full.
- The minimum age for taking part in this Event is 18 years old. You confirm that you will be the minimum age on race day.
- You acknowledge that you cannot swap, sell, or transfer your charity place in the Event or allow anyone else to participate on your behalf.
- You understand that LNAA has the right to refuse registration or application for a charity place in the Event without providing reasons for doing so at any time.
- You understand that to take part in the Event, you must complete the Event Organiser's online registration. Failure to complete this by the applicable deadline may mean you will be unable to participate in the Event.
- You understand that once you have chosen a running vest and this has been ordered by LNAA, you cannot request for another running vest in a different size or applicable personalisation.

- For your place in the London Landmarks Half Marathon 2026 you agree to pay a deposit of £20 which is non-refundable, non-transferable and cannot be used towards your fundraising target. This must be paid upon booking your space via our Eventbrite ticket system.
- You pledge to raise a minimum of £350 (excluding Gift Aid) whereby £50 is to be with LNAA no later than Sunday 1st February 2026, this is your first fundraising target. The remainder of the pledge is due by Sunday

10th May 2026. To guarantee your place in the Event you must reach your first fundraising target of £50 (excluding Gift Aid) by Sunday 1st February 2026. Failure to do so will put your place at risk resulting in your removal from the Event by LNAA. We will make contact with you as the first fundraising target date approaches if you have not yet reached the required amount.

- Should you decide to donate your minimum sponsorship (instead of fundraising) you understand that you must donate £50 (excluding Gift Aid and registration fee) of your minimum sponsorship to LNAA by Sunday 1st February 2026 to show your commitment to the charity place. Failure to do so can result in LNAA withdrawing your charity place from the Event. You must also donate the remainder of your fundraising target (£300 excluding Gift Aid) to LNAA by the final sponsorship deadline, Sunday 10th May 2026.
- The cost of your place is included in the pledged fundraising target and is covered by your fundraising, you are obliged to tell your sponsors that some of the money you raise will go towards the cost of you taking part unless you choose to donate to cover this cost.
- If at any point you feel like you are not on track to raise the minimum sponsorship of £350 (excluding Gift Aid and registration fee), please call 01522 548469 or email challenges@ambucopter.org.uk for immediate support with your fundraising plans.
- You understand that if the sum of £350 (excluding Gift Aid and registration fee) has not been paid by the final sponsorship deadline (Sunday 10th May 2026), then you agree to make up for the shortfall in funds pledged. For example, by personal donation.
- If you can no longer take part in the Event, please inform us at the earliest opportunity. You acknowledge that you will not be liable to raise any further sponsorship.
- All funds raised for the challenge must be payable to **The Lincolnshire and Nottinghamshire Air Ambulance Charity** in pound sterling.
- Should you, for whatever reason, not take your place, all sponsorship forms and monies collected should be forwarded to LNAA or returned to your sponsors.
- LNAA may ask for a fundraising plan at any point after registration for the Event.
- Any regular donations that you make to LNAA do not form part of the total raised through sponsorship (for example through our lottery or regular giving).

- If a donation is made to LNAA on a platform other than the online giving page, you must email challenges@ambucopter.org.uk with the payment date and method so that LNAA can confirm receipt.
- Please note that we encourage you to set up an online fundraising page to collect sponsorship but ask that you send us any donations you may have received directly, or from fundraising events you may hold to us within four weeks of the Event, along with any completed sponsorship forms where appropriate to enable us to reclaim an eligible Gift Aid.
- We will provide you with your unique donor number. Regular payments must be made via the following methods using your donor number as a reference;
 - Via the chosen online giving platform (we recommend Just Giving). The money will come directly into our bank account including any eligible Gift Aid. If you have raised any cash you can add it as offline donations to your page and send us a cheque, or you can bank the money and then pay it into your page.

- Not using the LNAA logo without permission. You will be issued with a 'In Aid Of' logo to help in your fundraising
- All fundraising materials must be requested from LNAA or approved by LNAA.
- Your fundraising must not include;
 - Raising funds by carrying out door-to-door, unsolicited or street collections
 - Conducting any raffle or lottery or putting on any public event without first contacting LNAA and taking any steps which are required lawfully
 - Collecting in private places without first obtaining the permission of the owner
 - Collecting in public places without first obtaining the appropriate collector's license from the local authority
- You are responsible for organising all aspects of your fundraising and LNAA will not accept any liability relating to your fundraising

Personal Data
